Dear Minister

Together we have a responsibility each and every day to make Queensland an even better place, to create opportunities, tackle challenges, and deliver for hardworking Queenslanders.

Easing cost-of-living pressures, delivering better healthcare and more housing, and keeping our communities safe are core priorities that we are all responsible for driving, regardless of which portfolio we lead. Collectively, we must also focus on safeguarding Queensland's future by lifting our ambition on climate action, while supporting new industries and creating jobs where they are needed most.

This letter outlines a range of delivery priorities in your portfolio, which I know you will work relentlessly towards achieving.

- progress further reforms to ensure the rental system is fair
- ensure Queenslanders experiencing or at risk of homelessness can access housing and homelessness supports
- ensure regional land-use planning is integrated with infrastructure planning to achieve local economic aspirations, positive housing outcomes and an enhanced lifestyle
- support local governments to thrive and deliver for their communities
- drive the continued rebuild of QBuild.

Listening to the voices of Queenslanders and working closely with other ministers will be essential to achieving meaningful outcomes. The priorities set out in the attached portfolio priority statement will also inform chief executive officer performance agreements and shape the functions and activities of departments and agencies.



## Delivery Priorities

<b>Housing</b>	<p>Deliver, in partnership with other relevant Ministers, the actions identified in the Queensland Housing Summit Outcomes Report.</p> <p>Drive delivery of additional social and affordable housing across the State, including through QuickStarts Queensland, the <i>Housing Investment Fund</i> and the Social Housing Accelerator program.</p> <p>Continue to implement the <i>Queensland Housing Strategy 2017–2027</i> and work with Ministers to deliver key actions in the <i>Aboriginal and Torres Strait Islander Housing Action Plan 2019–2023</i>, the <i>Housing and Homelessness Action Plan 2021–2025</i> and <i>Towards Ending Homelessness for Young Queenslanders 2022–2027</i>.</p> <p>Work with the Deputy Premier, Treasurer and Minister for Trade and Investment, and the Federal Government on the delivery of the National Housing Accord, including supporting Queensland's interests and the delivery of Queensland's commitments under the Accord.</p> <p>Work and engage with the Federal Government to support Queensland's interests in relation to housing, including: ensuring Queensland gets its fair share of allocations from the Housing Australia Future Fund; supporting the pending National Housing and Homelessness Plan, future funding arrangements and increased funding for Aboriginal and Torres Strait Islander housing; and ensuring federal regulatory settings optimally incentivise and facilitate housing supply.</p> <p>Support co-design and delivery of <i>Our Place: A First Nations Housing and Homelessness Action Plan 2024-27</i> and increase home ownership outcomes for Aboriginal and Torres Strait Islander people, including those living on Indigenous communal lands.</p> <p>Develop and deliver Stage 2 Rental Law Reforms, including developing legislation informed by consultation on the Stage 2 Rental Law Reform Options Paper, the <i>Ensuring the Annual Rent Increase Frequency Limit is Effective</i> discussion paper and Queensland commitments under National Cabinet's <i>A Better Deal for Renters</i>. Oversee the development of housing options to assist people to find affordable, accessible, sustainable and secure housing for sale or rent.</p> <p>Support the delivery of early interventions to improve outcomes for children, young people and families, and in turn break intergenerational cycles of disadvantage and help prevent youth offending. This will include delivery of housing, and housing and homelessness support, that assists young Queenslanders and families.</p> <p>Work with the Minister for Treaty, Minister for Aboriginal and Torres Strait Islander Partnerships, Minister for Communities and Minister for the Arts to support implementation of the National Agreement on Closing the Gap and Queensland's Housing Policy Partnership.</p> <p>Work with the Minister for State Development and Infrastructure, Minister for Industrial Relations and Minister for Racing and Economic Development Queensland to deliver significant housing projects, including in Priority Development Areas.</p>
<b>Local Government</b>	<p>Support remote, rural and regional local councils to apply for and implement the Works for Queensland program.</p> <p>Support councils throughout Queensland through other local government grant programs including the Indigenous Councils Funding Program and the South East Queensland Community Stimulus Program funding round.</p> <p>Continue to support the Independent Assessor in dealing with Local Government Council complaints more effectively.</p> <p>Continue to engage with Mayors and Councils on common interests and local government reform, including implementation of recent legislative amendments on Councillor Conduct.</p> <p>Deliver the QCoast<sub>2100</sub> 2.0 Program funding and related initiatives to assist councils to further develop and implement coastal hazard adaptation strategies.</p>

<p><b>Land Use Planning</b></p>	<p>Continue timely reviews of statutory regional plans to support long-term planning for state and local government, including sustainable economic development, and guide future infrastructure planning and investment that reflects state interests including coexistence of resources and other activities to contribute to prosperous and liveable regions.</p> <p>Work with other Ministers and relevant local governments to ensure appropriate plans, strategies and initiatives are in place to help implement national housing reforms agreed under the National Housing Accord and National Planning Reform Blueprint and state initiatives to enhance supply, affordability and diversity of housing particularly in well-located areas.</p>
<p><b>Public Works</b></p>	<p>Oversee the implementation of the building industry fairness reforms.</p> <p>Continue to investigate and implement actions to address non-conforming building products in Queensland for the health and safety of Queenslanders.</p> <p>Strengthen the Queensland Home Warranty Scheme, including consideration of a rating system to encourage quality building outcomes and coverage of residential buildings exceeding three storeys.</p> <p>Work with the Minister for Fire and Disaster Recovery and Minister for Corrective Services to deliver the <i>Resilient Homes Fund</i> so that Queenslanders can access grants to rebuild more resilient homes, raise homes or arrange a buy back of their high-risk home, in response to the 2022 flooding disaster.</p> <p>Support the implementation of the Queensland Government response to the <i>Queensland Building and Construction Commission (QBCC) Governance Review</i> to strengthen and transform the QBCC into a more customer and outcomes-focussed regulator.</p> <p>Work with the sector to ensure that licenses in the building and construction industry meet the professional standards that Queensland consumers and households deserve.</p> <p>Oversee the delivery of critical new housing for frontline staff such as police, health workers and teachers in remote locations.</p> <p>Support the roll out of <i>Rebuild QBuild Phase 2</i> creating more jobs for trades and apprentices, help deliver construction, including through Modern Methods of Construction, and maintenance services to regional and remote areas of the state and support the Government's response to natural disasters.</p>
<p><b>National Agreements, National Partnerships &amp; Significant National Reform Projects</b></p>	<p>Support the Deputy Premier, Treasurer and Minister for Trade and Investment in relation to negotiation, management and implementation of any intergovernmental funding agreements relevant to your portfolio.</p> <p>Proactively advocate to the Federal Government and engage with states and territories to ensure Queensland's interests are reflected in the development of the National Housing and Homelessness Plan and the next National Housing and Homelessness Agreement and ensure a fair share of funding for Queensland.</p> <p>Represent Queensland on National Ministerial forums relevant to your portfolio.</p> <p>Proactively engage with your Federal Government counterparts and states and territories to ensure Queensland is well placed to leverage key opportunities associated with the commitments made by the Federal Government and advocate for a fair share of funding for Queensland.</p>
